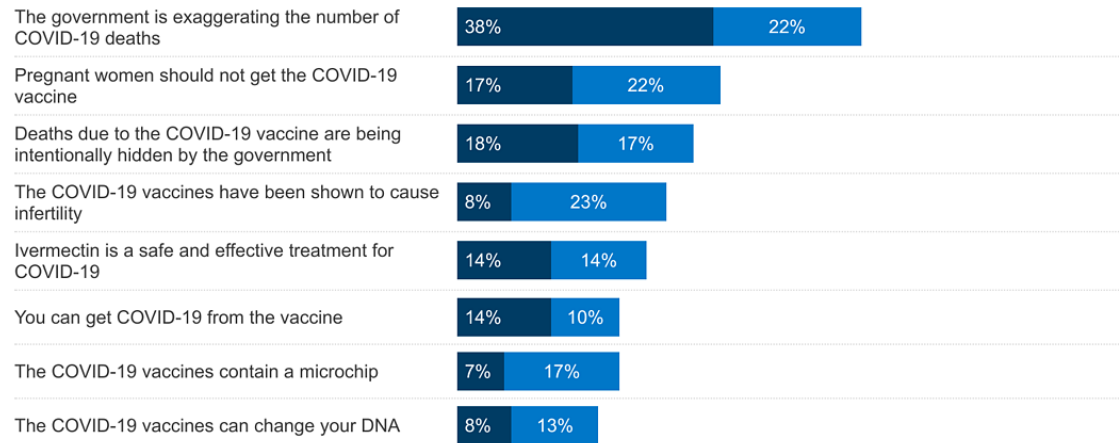

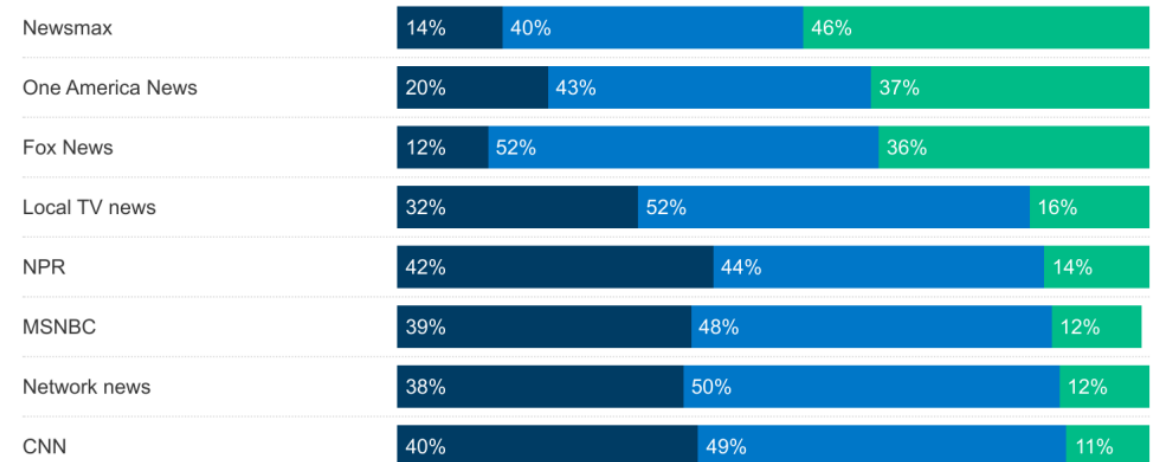

# CA Extremism

## ABSTRACT

Recent alterations to violent groups in the United States and to the composition of the two main political parties have created a latent force for violence that can be 1) triggered by a variety of social events that touch on a number of interrelated identities; or 2) purposefully ignited for partisan political purposes. This essay describes the history of such forces in the U.S., shares the risk factors for election violence globally and how they are trending in the U.S., and concludes with some potential paths to mitigate the problem.

## LEFT-WING TERRORISM

The far-left includes a decentralized mix of actors. Anarchists are fundamentally opposed to a centralized government and capitalism, and they have organized plots and attacks against government, capitalist, and globalization targets.<sup>39</sup> Environmental and animal rights groups, such as the Earth Liberation Front and Animal Liberation Front, have conducted small-scale attacks against businesses they perceive as exploiting the environment.<sup>40</sup>

## RELIGIOUS TERRORISM

While religious terrorism is concerning, the United States does not face the same level of threat today from religious extremists—particularly those inspired by Salafi-jihadist groups such as the Islamic State and al-Qaeda—as some European countries.<sup>44</sup> But Salafi-jihadists still pose a limited threat. In December 2019, Second Lieutenant Mohammed Saeed Alshamrani, a Saudi air force cadet training with the American military in Pensacola, Florida, killed three men and injured three others. He was inspired by al-Qaeda’s ideology, communicated with leaders of al-Qaeda in the Arabian Peninsula up until the attack, and joined the Saudi military in part to carry out a “special operation.”<sup>45</sup>

## White Nationalist

White nationalist groups base their viewpoints around the false, unfounded idea that nonwhite people are inferior to white people.

## Orders Oath Keepers “refuse”:

1. We will NOT obey orders to disarm the American people.
2. We will NOT obey orders to conduct warrantless searches of the American people.
3. We will NOT obey orders to detain American citizens as “unlawful enemy combatants” or to subject them to military tribunal.
4. We will NOT obey orders to impose martial law or a “state of emergency” on a state.
5. We will NOT obey orders to invade and subjugate any state that asserts its sovereignty.
6. We will NOT obey any order to blockade American cities, thus turning them into giant concentration camps.
7. We will NOT obey any order to force American citizens into any form of detention camps under any pretext.
8. We will NOT obey orders to assist or support the use of any foreign troops on U.S. soil against the American people to “keep the peace” or to “maintain control.”
9. We will NOT obey any orders to confiscate the property of the American people, including food and other essential supplies.
10. We will NOT obey any orders which infringe on the right of the people to free speech, to peaceably assemble, and to petition their government for a redress of grievances.

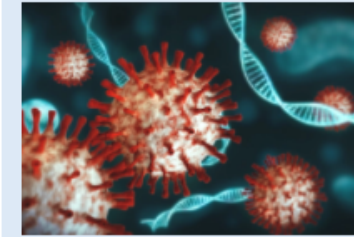

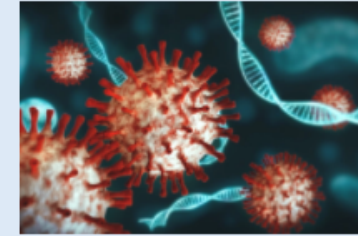
