

<u>What are the past, present and future effects of</u> <u>Covid-19 on our health?</u>


- **First-order effects:** These are the direct effects of the virus: infections, deaths and the condition known as long Covid.
- **Second-order effects:** These are indirect effects, largely in the short to medium term, stemming from measures implemented to control the pandemic. They include unmet health needs arising from the NHS backlog, and the mental health effects of lockdowns.
- **Third-order effects:** These are longer-term, indirect effects caused by the impact of the virus on key social influences on our health, particularly employment and education.





- The war in Ukraine could lead to a food crisis on a global' scale.
- Ukraine plays a major role in the global food system. Together with Russia, the two countries account for a combined 12% of the food calories traded in the world.
- The proliferation of conflicts and the multiplication of extreme climate events, against the backdrop of the Covid-19 global economic recession and growing inequalities, has increased rapidly and consistently the number of food insecure people globally.
- "Conflict and hunger are closely intertwined when one escalates, the other usually follows. As in any crisis, it is the poorest and most vulnerable who are hardest hit, and in our globalized world, the impact of this conflict will reverberate across continents."

### War Threatens to Cause a Global Food Crisis

The war in Ukraine has delivered a shock to global energy markets. Now the planet is facing a deeper crisis: a shortage of food. A crucial portion of the world's wheat, corn and barley is trapped






- Both Ukraine and Russia have a significant share world wheat and corn market which is now threatened by the war in Ukraine.
- Ukraine is also the world's third biggest exporter of corn, while Russia and Belarus, which is also under sanctions, produce over a third of global fertilizers.
- We view these supply bottlenecks in the context of feeding an evergrowing population which will hit
   9.7 bln by 2050.
- To overcome this challenge agricultural yields need to be boosted by mechanization, better use of water, fertilizers and crop technology as well as precision agriculture.
- The USDA estimates that China holds half of the world's wheat reserves and 70% of its corn.
- After five consecutive record crops, India has almost one-tenth of global wheat stockpiles.
- The U.S. has 6% and 12% of global wheat and corn reserves, respectively.

### The Russian Federation: The most important source of global fertilizer supplies





"Food costs were increasing even before the Ukraine war, driven by higher energy prices, transport bottlenecks and, in some countries, farm labor shortages. Now Russia's invasion has triggered further rises and concerns about prolonged disruption in agriculture-rich Ukraine."



### **The Food Insecurity Experience Scale**

Food insecurity can also be defined by its duration.

Acute: When the inability to consume enough food puts a person's life in immediate danger. Chronic: When a person is unable to meet minimum food requirements over a sustained period. Seasonal: When a person experiences a cyclical pattern of inadequate access to food.


When a country or region has widespread food scarcity—meeting certain measures of malnutrition, undernourishment, and mortality—humanitarian agencies will declare a **famine**. Factors including displacement and disease outbreaks are also considered.



### Acute food insecurity phase description and response

Phase	Phase description and priority response objective
Phase 1 <b>None/Minimal</b>	Households are able to meet essential food and non-food needs without engaging in atypical and unsustainable strategies to access food and income. Action required to build resilience and for disaster risk reduction.
Phase 2 Stressed	Households have minimally adequate food consumption but are unable to afford some essential non-food expenditures without engaging in stress-coping strategies. Action required for disaster risk reduction and to protect livelihoods.
Phase 3 <b>Crisis</b>	<ul> <li>Households either:</li> <li>Have food consumption gaps that are reflected by high or above-usual acute malnutrition; or</li> <li>Are marginally able to meet minimum food needs but only by depleting essential livelihood assets or through crisis-coping strategies.</li> <li>URGENT ACTION required to protect livelihoods and reduce food consumption gaps.</li> </ul>
Phase 4 <b>Emergency</b>	<ul> <li>Households either:</li> <li>Have large food consumption gaps which are reflected in very high acute malnutrition and excess mortality; or</li> <li>Are able to mitigate large food consumption gaps but only by employing emergency livelihood strategies and asset liquidation.</li> <li>URGENT ACTION required to save lives and livelihoods.</li> </ul>
Phase 5 Catastrophe/Famine	Households have an extreme lack of food and/or other basic needs even after full employment of coping strategies. Starvation, death, destitution and extremely critical acute malnutrition levels are evident. (For Famine classification, area needs to have extreme critical levels of acute malnutrition and mortality.) Famine and Famine Likely classifications are equally severe, the only difference is the amount of reliable evidence available to support the statement. <b>URGENT ACTION required to revert/prevent widespread death and total collapse of livelihoods.</b>





Approximately 73% of winter wheat production is within an area experiencing drought.

Wheat prices are surging globally in the wake of the conflict between Russia & Ukraine. Prior to this development, prices were already elevated, influenced by relatively tight supplies in key exporting countries. Major exporter ending stocks are collectively projected as the lowest since 2012/13.

The United Nations recommends six ways to transform food systems to address food security:

1. Integrating humanitarian, development and peacebuilding policies in conflict-affected areas.

2. Scaling up climate resilience across food systems.

3. Strengthening the resilience of the most vulnerable to economic adversity.

4. Intervening along the food supply chains to lower the cost of nutritious foods.

5. Tackling poverty and structural inequalities, ensuring interventions are pro-poor and inclusive.

6. Strengthening food environments and changing consumer behavior to promote dietary patterns with positive impacts on human health and the environment.

Conflict conditions make it harder for people to access nutritious food.
